Learn about updates to animal welfare audits from industry leaders.

NAMI – North American Meat Institute – Dr. Tiffany Lee, Director, Scientific & Regulatory Affairs *Meat Plant Standards & Auditing Update*

Major change: addition of FQA document. Minor changes will be included annually with major changes being updated by NAMI Animal Welfare Committee with assistance from Dr. Grandin annually.

Minor changes:

- Clarified definition of security stun vs. double-knock.
- Clarification on auditing the bleed rail.
- Moved audit point for gondola loading to effective stunning criteria.
- Clarified point of entry for captive bolt in sheep.
- Emphasized electric prod use, whether the prod was energized or not.
- Pig audit minor edits; accurate placement, effective stunning and hot wandering.

FARM – Farmers Assuring Responsible Management – Beverly Hampton Phifer, Stakeholder Relations Manager *Dairy Standards & Auditing Update*

- USDA grant focused on biosecurity.
- All program cycle extended for additional 6 months. Current cycle will remain in place through June 30,2024
- Version 4 Priorities
 - No routine tail docking
 - o Veterinarian review
 - Non-ambulatory practices & protocol
 - Euthanasia practices & protocol
 - Animal observations benchmark
 - Fitness of transport protocol and more
- Version 4 Corrective Action Updates
 - o Immediate, resolution within 48 hours.
 - o Mandatory Corrective, resolution within 9 months
 - Continuous Improvement, resolution within 3 years
- Updated Evaluator resources and pocket guide available.

New Tool NCBA – National Cattlemen's Beef Association - Josh White, Producer Education & Sustainability Beef Feedyard Standards & Auditing Update

- Rooted in BQA Feedyard assessment auditors will be BQA certified.
- Designed to be industrywide audit to be used as baseline for industry implementation.
- Facilitated between Feedyard and "audit owner."
- NCBA membership funded tool but NCBA will not conduct audits.
- Based on business-to-business relationship.
- BQA team is updating Feedyard Assessment.

NCFA - National Cattle Feeders' Association – Dr. Joyce Van Donkersgoed, Animal Care Program Manager *Beef Feedlot Standards & Auditing Update*

- Commitment to Animal Care
 - o Feedlot must complete a BQA certification training program specific to feedlots within last 3 yrs.
- Nutrition & Feed Management feedlot must have <u>written feeding program</u> as required by CFIA.
- Clarification to Feeding Records, documented as per CFIA Feed Regulations.
- Animal Health Management added that feedlot has documented biosecurity procedures and feedlot visitor log.
- Animal Health Management feedlot has a broken needle protocol, shipping protocol and shipping records.
- Animal Health Management addition of abortion protocol & plan to manage calving heifers, antimicrobial stewardship protocol and cattle health product management protocol & records.
- On-farm Humane Stunning/Euthanasia feedlot must have record listing personnel trained & approved to
 euthanize animals and feedlot disposes of carcasses as per provincial regulations.
- Clarified sample size of pens to assess to align with standards.
- Audit scoring added that a numerical score of 10.
- Audit competency auditors must complete NCBA's Feedlot BQA or VBP+ training program within the last 3
 years and auditors must annually complete NCFA's eLearn training program for PAACO certified Canadian
 Animal Care Assessment Program.

- Databases were created, audit scoring as reference for updates and scratches data collection.
- Animal Handling at least two point on contact.
- Confirm insensibility/death to AASV guidelines Q5.
- Scratches criteria and questions Q21 & Q22.
- New training tools coming soon.
 - CSIA Producer Training
 - Swine Welfare Auditor Repeatability
 - Swine Welfare Auditor Pocket Guide

Poultry Standards & Auditing Update

2019 Breeder Audit update – omit Section C and all associated points. 2019 Broiler and Breeder Audit updates:

- D2, Verifying mill meeting GMP's simply verify mill is registered with FDA and/or has documented GMP's for feed production.
- D3, Biosecurity program will need to be <u>written</u> program must be designed, established, & implemented to minimize any negative impacts on bird welfare & protect flock health.
- D4, Changes to Health Care & Monitoring, flocks must be inspected at <u>least</u> twice daily, and all mortality must be removed at least once daily.
- D4, Removal of wording timely manner.
- E, Catching removal of working timely manner.
- E, Catching number of trailers evaluated for handling defined. A min. of 5 & max. of 10 cages.
- E, Catching defined how many trailers to evaluate for birds in single layer. A min. of 5 & max. of 10.
- F, Processing Clarify that 500 birds on <u>each</u> shackling & stun/slaughter line.
- F, Processing Paw scoring will be scored at plant, but score will be applied to Growout Section.

2020 Broiler Audit updates:

- Addition to Hatchery audit, embryonated eggs that are removed should appropriately euthanized during the same shift in which they are removed from system.
- Definition of "Qualified Auditor."
